Rules for guests with pets

In keeping with our tradition of hospitality and to meet the needs of our guests, we have defined rules of Dom Lardy for our guests with pets. Guests will only be able to come and stay with their pets in our glamping tents.

THE FOLLOWING TYPES OF PETS ARE ALLOWED AT OUR HOTEL PETS: small pets under 7 kg of decorative weight. Our receptionist reserves the right to determine whether or not this animal may stay in the room. PETS: small pets under 7 kg of decorative weight. Our receptionist reserves the right to determine whether or not this animal may stay in the room. When coming with pets it is the guest's responsibility to read the "Policy for Guests with Pets" and sign a form stating that he/she accepts and approves of this policy. It is mandatory to have a veterinary passport for the pet. Compulsory payment of a SPECIAL ADDITIONAL CHARGE OF TREATMENT AND DISINFECTION OF THE ROOM after check-out. ROOM DISINFECTION AFTER THE DEPARTURE OF GUESTS WITH DOGS IS 3000 RUBLES. CHARGEABLE UPON RESERVATION.

1. OBLIGATIONS OF PET OWNERS WHEN STAYING AT DOM LARDY

A guest staying with an animal will undertake the following:

- The owner is obliged to have a special mat or kennel for the pet.
- The owner must have a special litter box for his animal
- The owner is required to have his feeding station for his animal.
- Dogs must be kept on the premises only with a muzzle and/or a leash.
- Allowed to be kept on the premises ornamental breeds (small dogs). They may be kept in the hands of the owner
- It is the owner's responsibility to ensure that pets are not in the room during cleaning or renovation work.
- Pets must NOT be left unattended by their owners in our rooms, in the lobby or elsewhere.
- Hunting, patrolling and fighting breeds are FORBIDDEN.
- Check in with animals that do not meet the criteria of "small dogs" is not permitted.
- No more than one pet can stay in the same room
- People with reduced mobility are allowed to stay with their guide dogs to meet all of their needs.
- 2. RESTRICTIONS ON ACCOMMODATION WITH PETS
 - You may not bring pets into the dining hall or common areas.
 - You may not feed pets from household ware, belonging to Dom Lardy.
 - Do not use hotel furniture for the resting of pets.
 - Pets may not be left unattended in the room without a cage. Pets may not be left unattended in public areas, on the grounds.
 - Pets must not be allowed on the playground or in areas where flowers are planted.
 - Walking pets is not permitted at playgrounds and flowerpots.
 - It is forbidden to wash pets in the showers.
 - Washing pets in showers, bathtubs or bathrooms and using towels, sheets or other bedding for hygiene is prohibited.
 - You must not brush pets in your room.
- 3. THE RESPONSIBILITY OF THE PET OWNER
 - The owner takes full responsibility for dealing with problems of feeding, cleaning and walking the pet.
 - The owner keeps the pet on a leash wherever there are third parties persons.
 - The owner is fully responsible for possible damage to property caused by a pet. The owner shall pay the fee according to the price list valid at the time of the owner's stay.
 - The owner shall be fully responsible for cleaning up the animal's waste.
 - The owner is fully responsible for the care and disposal of the animal waste in special bags.

- The owner shall bear all risks towards the Administration and third parties arising from the behavior of the animals at the time and conditions of their stay in the accommodation facility.
- 4. CONDITIONS FOR TERMINATION OF THE CONTRACT WITH A GUEST STAYING WITH PETS The management reserves the right to terminate the contract: in case of violation of the "Policy for Guests with Pets", aggressive, inappropriate, noisy behavior of pets, the creation of inconvenience to the comfort of other guests and visitors.
